This PIN provides the importing community with an updated list of agriculture commodities on the National Agriculture Release Program (NARP). This PIN updates PIN 2019-006 issued on August 09, 2019.

The NARP program was instituted nation-wide on January 8, 2007 and identifies specific low risk/high volume agriculture commodities from Mexico that will be inspected at a reduced rate. NARP allows for more efficient utilization of resources and uses national and local criteria to systematically sample commodities while adjusting to rapidly changing risk profiles without compromising agricultural quarantine and plant health safeguards. NARP applies mostly to fresh fruits and vegetables with minor application to those that are frozen and semi-processed.

The updates to the guidelines are summarized below. However, please note the following updates in particular:

- **Added Brussels Sprouts and Spinach to NARP list.**

- Prickly Pear Fruit (AKA Tuna, Xoconostle)
- Pumpkin
- Raspberry
- Snap Pea (NOT Snow, NOT Chickpea, NOT Black Eyed Pea)
- Spinach
- Strawberry
- Tomato (NOT Husk Tomato/NOT Tomatillo)
- Watermelon

PROCEDURES:

Upon arrival to the primary inspection at the Otay Mesa Commercial facility, drivers will present one additional manifest copy for the NARP agriculture commodities listed above.

Customs and Border Protection Officers will instruct drivers as to whether they will be released from primary or if they will need to report to the inspection dock. Drivers arriving without the additional manifest copy will need to report to the inspection dock. Other procedures in place may result in any specific shipment being designated for examination.

While shipments that contain only NARP listed commodities are allowed to go gate to gate, on occasion NARP shipments will require secondary processing. NARP commodities which are commingled with Non-NARP commodities will be sent to the dock for examination. This expedited process (based on low risk pest and plant disease history, and high volume) may be susceptible to change at any time due to the interception of pests, diseases or contaminants.
